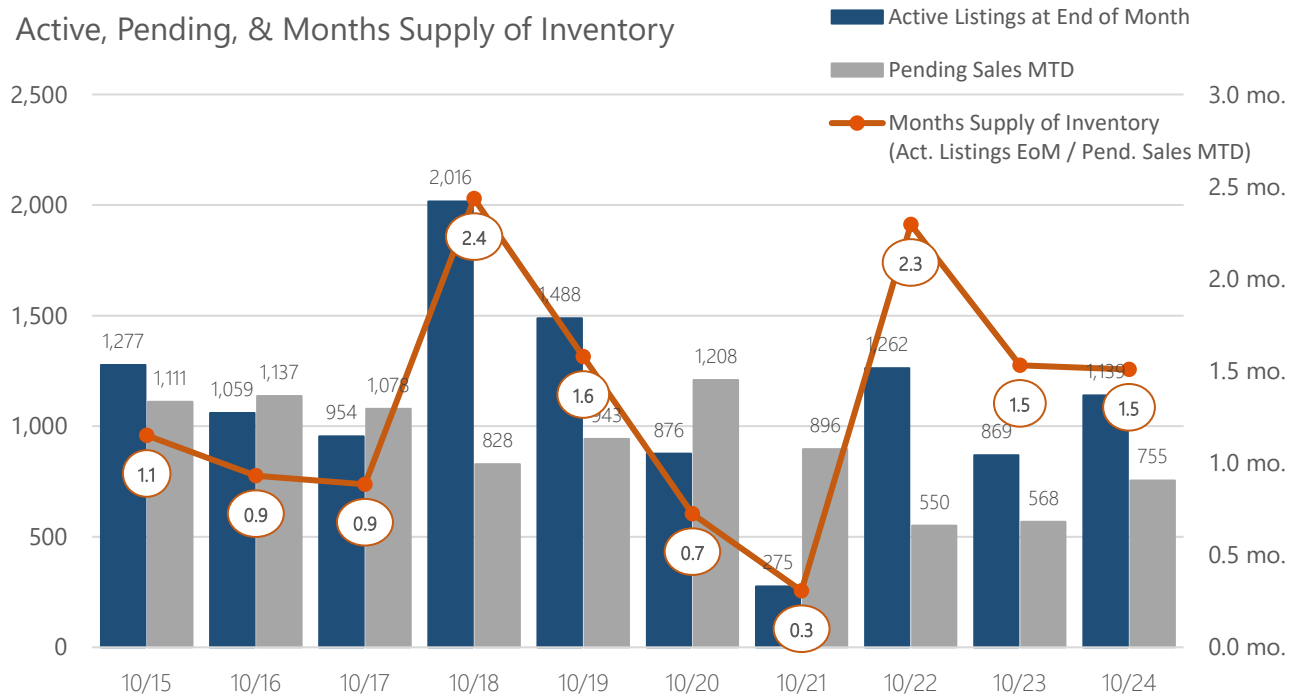
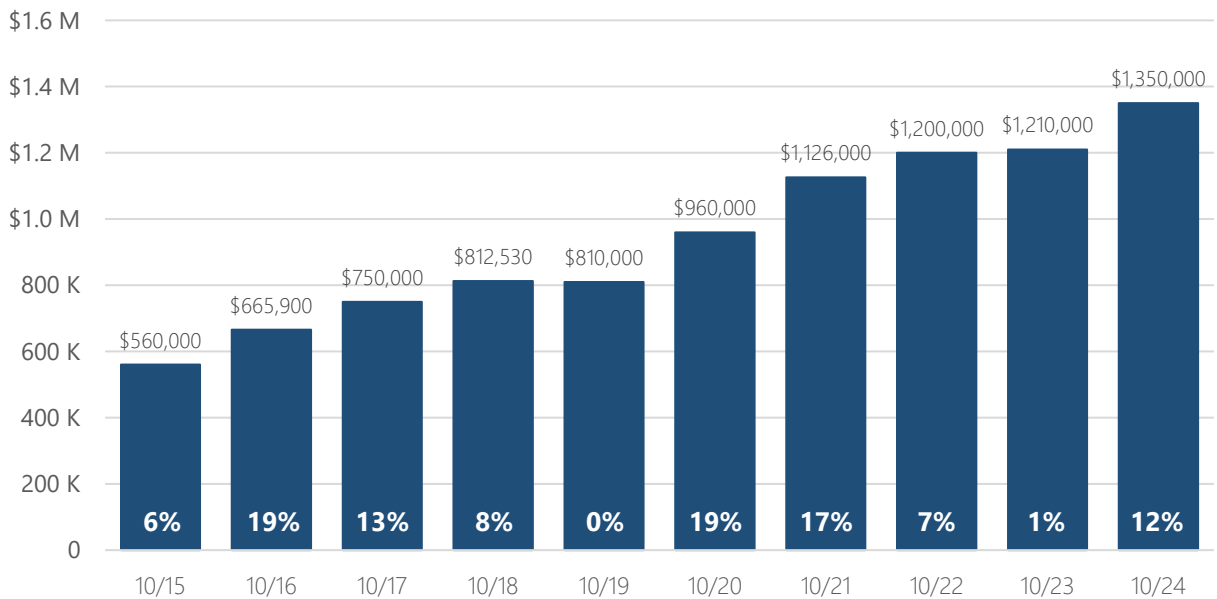

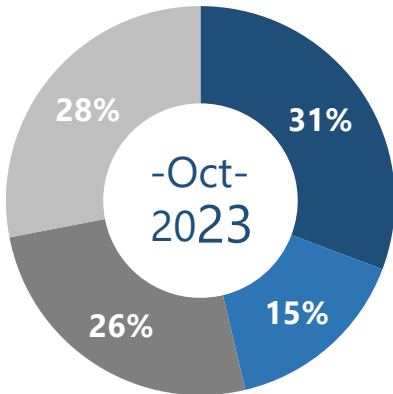
Median Closed Sales Price For Current Month Sold Properties



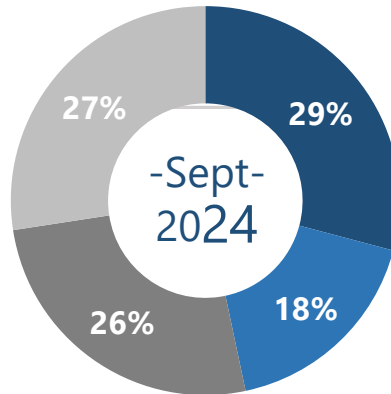

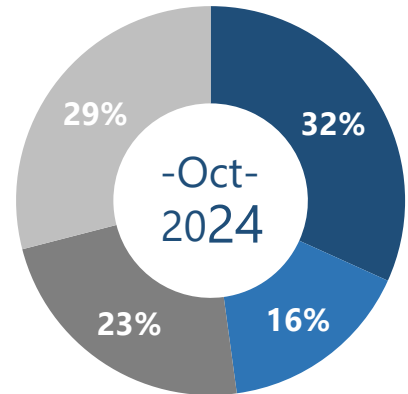
PERCENTAGE OF LISTINGS SOLD ABOVE, AT, BELOW LIST PRICE AND WITH A PRICE CHANGE

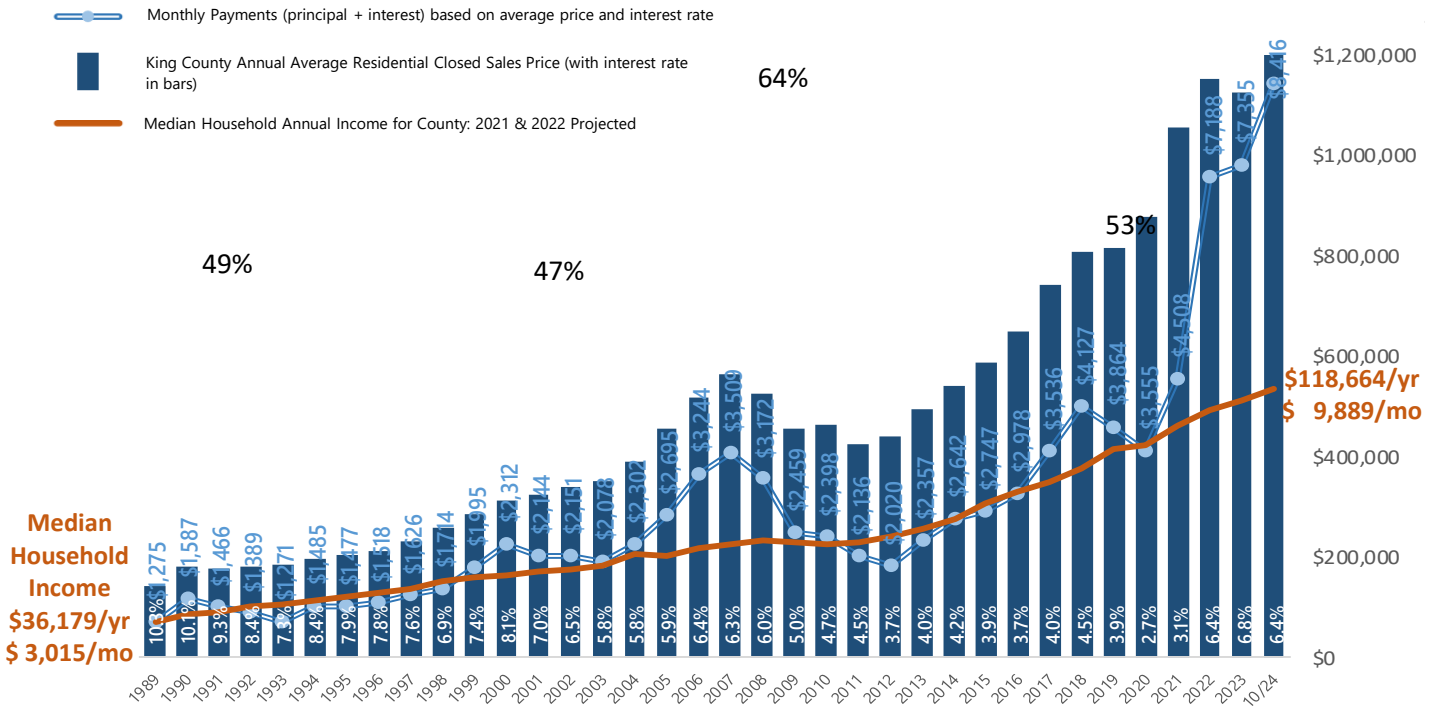

# Monthly Payments Compared to Income Trendline King County



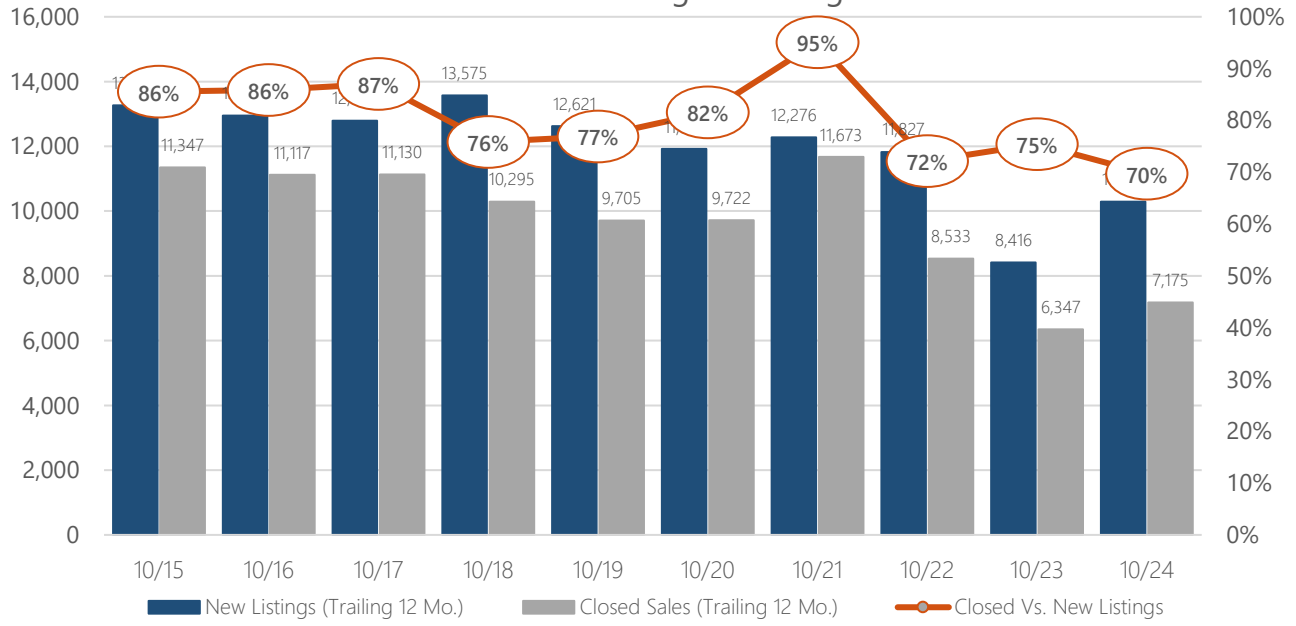

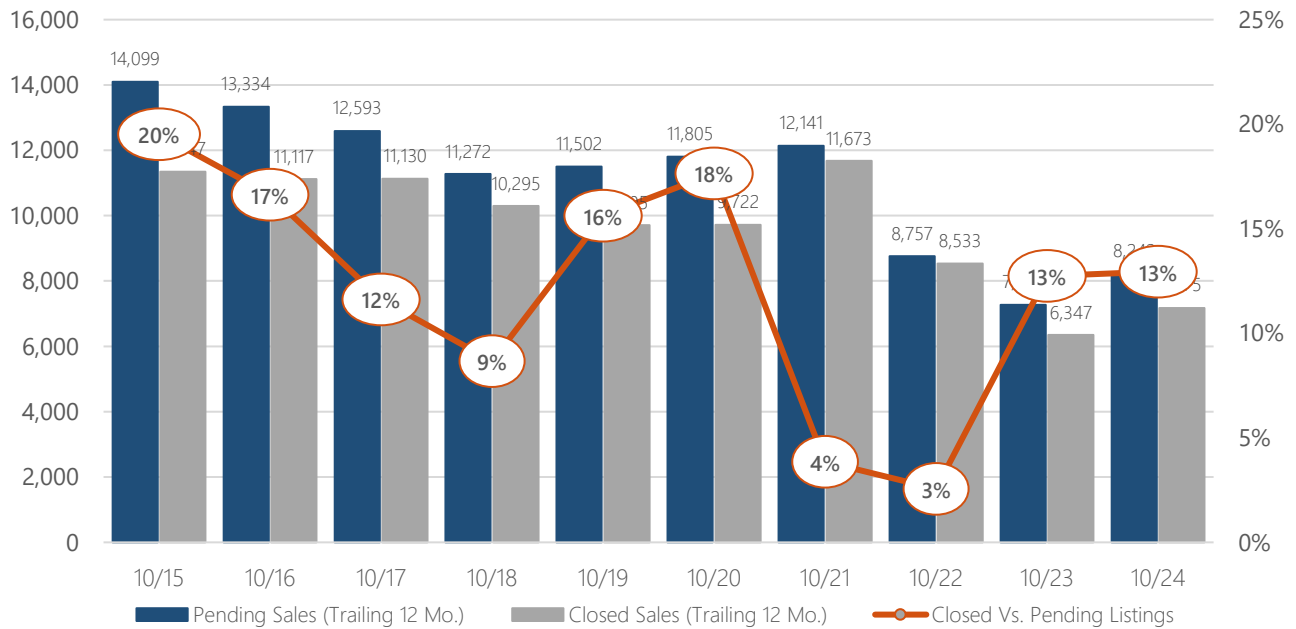
